# **Requirements for abstracts**

Scientific articles are submitted in electronic form. The article can be submitted in Kazakh, Russian, English. A translation into English of the work title, information about the author (name, place of study/work), annotation (80-100 words) and keywords are required. A sample of the article is presented in Appendix 1. The volume of a scientific article of student works should not exceed 3 pages in A4 format, for master's students - at least 4 pages in A4 format.

All articles are checked for originality (plagiarism). The volume of the borrowed text must not exceed 30% (originality is at least 70%), all borrowings must be correctly formatted, all sources must be included in the list of cited literature.

#### **Installations:**

- 1. UDC (Universal decimal classification)
- 2. annotation in 3 languages (80-100 words)
- 3. key words (in 3 languages)
- 4. margins: top, bottom, left and right 2 cm
- 5. font: Times New Roman, size (point size) 12.
- 6. orientation portrait
- 7. line spacing single
- 8. alignment of the font in width;
- 9. paragraph indent 1.25 cm
- 10. It is not allowed to insert page breaks, section breaks, dividing text into columns, using automatic lists, hidden text, macros and other additional formatting.
